amending Regulation (EC) No 333/2007 as regards the methods for of sampling and analysis for the control of levels of iodine in foodstuffs.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2017/625 of the European Parliament and of the Council of 15 March 2017 on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products, amending Regulations (EC) No 999/2001, (EC) No 396/2005, (EC) No 1069/2009, (EC) No 1107/2009, (EU) No 1151/2012, (EU) No 652/2014, (EU) 2016/429 and (EU) 2016/2031 of the European Parliament and of the Council, Council Regulations (EC) No 1/2005 and (EC) No 1099/2009 and Council Directives 98/58/EC, 1999/74/EC, 2007/43/EC, 2008/119/EC and 2008/120/EC, and repealing Regulations (EC) No 854/2004 and (EC) No 882/2004 of the European Parliament and of the Council, Council Directives 89/608/EEC, 89/662/EEC, 90/425/EEC, 91/496/EEC, 96/23/EC, 96/93/EC and 97/78/EC and Council Decision 92/438/EEC (Official Controls Regulation)¹, and in particular Article 34(6) thereof,

Whereas:

- (1) Commission Regulation (EC) No 333/2007² lays down the methods of sampling and analysis to be used for the control of the levels of trace elements and processing contaminants in foodstuffs.

- (2) Commission **Recommendation (EU) XXXX/2027** recommends an indicative level for iodine in certain categories of foodstuffs.
- (3) In order to ensure the reliability and consistency of controls on the levels for iodine in certain foods, specific requirements should be set in Regulation (EC) No 333/2007 for the methods used for sampling and for laboratory analyses as regards iodine.
- (4) **In the Annex to regulation (EC) No 333/2007 the abbreviation of maximum level to ML should be added.**
- (5) Regulation (EC) No 333/2007 should therefore be amended accordingly.
- (6) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EC) No 333/2007 is amended as follows:

- (1) Article 1.1 is replaced by the following:

‘Article 1

1. Sampling and analysis for the control of the levels of lead, cadmium, mercury, inorganic tin, inorganic arsenic, nickel, iodine, 3-monochloropropane-1,2-diol (3-MCPD), 3-MCPD fatty acid esters, glycidyl fatty acid esters, polycyclic aromatic hydrocarbons (PAH), mineral oil hydrocarbons (MOH) and perchlorate listed in Sections 3, 5 and 6 of Annex I to Regulation (EU) 2023/915 (*) and for the control of the levels of acrylamide in accordance with Commission Regulation (EU) 2017/2158 (**) shall be carried out in accordance with the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
