THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 396/2005 of the European Parliament and of the Council of 23 February 2005 on maximum residue levels of pesticides in or on food and feed of plant and animal origin and amending Council Directive 91/414/EEC¹, and in particular Article 14(1), point (a), thereof,

Whereas:

(1) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

- (2) An error appears in Article 2 of Commission² which sets out the same date of application and of entry into force.
- (3) The error appeared when Commission Regulation (EU) 2025/581 did not indicate a specific application date.
- (4) Commission Regulation (EU) 2025/581 shall apply from 1 May 2025 in order to be coherent with Commission Regulation (EU) 2024/2619 of 8 October 2024 which applies from 29 April 2025 and with Commission Regulation (EU) 2024/2640 of 9 October 2024 which applies from 30 April 2025.
- (5) Commission Regulation (EU) 2025/581 should therefore be corrected accordingly.
